



Virtual Helpdesk Ltd GDPR Compliance Policy

1. Introduction

This policy outlines Virtual Helpdesk's commitment to comply with the General Data Protection Regulation (GDPR) as it pertains to the processing of personal data of individuals within the United Kingdom. 2. Objectives

6. Rights of Data Subjects

Data subjects have the following rights under the GDPR:

- Right to access: Individuals can request access to their personal data.
- Right to rectification: Individuals can request correction of inaccurate or incomplete personal data.
- Right to erasure: Individuals can request deletion of their personal data under certain conditions.
- Right to restrict processing: Individuals can request restrictions on the processing of their personal data.
- Right to data portability: Individuals can request to receive their personal data in a structured, commonly used format and transfer it to another data controller.
- Right to object: Individuals can object to the processing of their personal data in certain circumstances.

7. Data Protection Officer (DPO)
